04. First-aid measures

General

In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person. Immediately remove all contaminated clothing. Unconsciousness: lateral position - call a physician.

After inhalation

Remove concerned person out of danger area. Take the casualty into the fresh air and keep warm. Let in fresh air. Irregular breathing/no breathing: artificial respiration.

After eye contact

Remove contact lenses, keep eyelids open. Flush with plenty of water (10 - 15 min.). Call a physician.

05. Fire-fighting measures

Suitable extinguishing media

Alcohol resistant foam, CO₂, powders, water spray.

Unsuitable extinguishing media

Waterjet.

Special risk posed by the substance or by the actual preparation, its combustion products or gases discharged

Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard.

Special protective equipment

In case of fire do not breathe fumes. When extinguishing fires, use breathing apparatus with an independent source of air.

Additional information

06. Accidental release measures

Personal precautions

Remove ignition sources. Provide for sufficient ventilation. Refer to protective measures listed in sections 7 and 8.

Environmental precautions

Do not empty into drains. If the product contaminates lakes, rivers or sewages, inform appropriate authorities in accordance with local regulations.

Methods for cleaning up/collecting

Contain and collect spillage with non-combustible absorbent materials, e.g. sand, earth, vermiculite, diatomaceous earth and place in container for disposal according to local regulations (see section 13).

07. Handling and storage

Information for safe handling

Prevent the creation of inflammable or explosive concentrations of vapour in air and avoid vapour concentrations higher than the OEL (=Occupational Exposure Limit). Additionally, the product should only be used in areas from which all naked lights and other sources of ignition have been excluded. Comply with the health and safety at work laws.

Information about protection against explosions and fires

Vapours are heavier than air and may spread along floors. Vapours may form explosive mixtures with air. Keep away from ignition sources and provide for good ventilation. Preparation may charge electrostatically: always use earthing leads when transferring from one container to another.

Requirements to be met by storerooms and containers

Containers which are opened must be carefully resealed and kept upright to prevent leakage. Keep container tightly closed. Never use pressure to empty: container is not a pressure vessel. No smoking. Prevent unauthorized access.

Information about separation of incompatible products

Keep away from oxidizing agents, from strongly alkaline and strongly acid materials.

Further information about storage conditions

Always keep in containers of same material as the original one. See also instructions on the label. Avoid heating and direct sunlight.

08. Exposure controls/personal protection

Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of particulates and solvent vapour below the OEL (=Occupational Exposure Limit), suitable respiratory protection must be worn.

10. Stability and reactivity
